The Expedia Singapore Family Showdown Terms and Conditions:

1. The **Expedia Singapore Family Showdown** contest (hereinafter "**Contest**") is open to citizens and permanent residents of Singapore, aged 13 to 19 years and above as stated on their NRIC/Passport (as of date of entry) ("**Participant**"). 4. The Organiser retains the right to substitute the Prize with another in the event the original Prize offered is not available due to circumstances beyond its reasonable control.
5. By participating in this Contest, each Participant agrees to be bound by these Terms and Conditions. All rules and regulations and instructions issued by AAE Travel Pte Ltd ("**Expedia**") ("**Organiser**") from time to time will be deemed incorporated in these Terms

8. An "Affiliate" shall refer to any entity (whether a person, corporation, partnership or otherwise) that directly or indirectly, controls, are controlled by, or are under common control with the Organiser. An entity shall be deemed to be in "control" of another entity when it holds fifty (50%) percent or more of voting shares in that entity or has management control of that entity. The Organiser and its Affiliates shall be referred to as the "AAE Group".
9. The Organiser will communicate with Participants by (a) email at the email address provided, or (b) on **Teenage.com.sg** or any other website that may be generally designated for such purpose. Each Participant consents to receiving electronically all agreements, notices, disclosures and other related communications from the Organiser.
10. The Organiser reserves the right to disqualify any Participant(s) suspected of fraud or if the Organiser believes that any Participant's results have been manipulated.
11. The Organiser reserves the right to change or substitute any prize(s) to other prize(s) of comparable or other value if deemed necessary. Prize(s) are not exchangeable for cash.
12. All decisions by the Organiser are deemed final and no correspondence or further claims will be entertained.
13. If this Contest is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the Organiser's control, the Organiser reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) to modify, suspend, terminate or cancel the Contest, as appropriate.
14. The Organiser makes no guarantee of the availability of its web services and will not be held responsible for interruption of service that may interfere with the ability to participate in the Contest.

15. The Participant warrants that the entries submitted by the Participant for the Contest (“**Entry**”) do not contain any defamatory, offensive or unlawful content, comply with all applicable laws, and do not infringe any third party rights (“**Warranties**”).
16. By participating in the Contest, the Participant hereby affirms and declares that the Releasees are not responsible for any violation or infringement of the Warranties. The Participant irrevocably indemnified the Releasees against any claims, losses, damages, expenses (including attorney’s fees), proceedings, suits or losses which may arise out of or in connection with the Entry. In the event that the Entry by the Participant wins the Contest, and is later on challenged on the ground of infringement or breach of any of the Warranties, the Releasees shall have right to enforce their legal rights against such Participant and will also have the right to disqualify him/her from participating in this Contest.

The Organiser reserves the right to publish or display materials or information, including but not limited to the Entry and the names and photographs of all Participants for marketing, advertising and publicity purposes in any manner it deems appropriate. For the avoidance of doubt, the Participants acknowledge and agree that, if the Participant is shortlisted to take part in the Expedia Singapore Family Showdown, the Entry and materials submitted for the Expedia Singapore Family Showdown shall also be governed by this Terms of Conditions.
20. The Participants further agree and consent to the AAE Group collecting, using, disclosing and sharing amongst themselves the Participants' personal data, and disclosing such personal data to the AAE Group's authorised service providers and relevant third parties for purposes which are necessary or reasonably incidental to the Contest, and to market, advertise and/or promote the goods or services of the AAE Group, including without limitation using videos and/or images of the Participants for publicity purposes.

By participating in the Contest, the Participants agree to take part in any promotion or publicity exercise as may be conducted by the AAE Group and the Participants hereby irrevocably and unconditionally grant the AAE Group all consents and waivers necessary for the AAE Group, its representatives and contractors to record and use the Participants' performance, appearance, likeness, name, voice and/or particulars (as the case may be) in any manner as the AAE Group shall in its sole discretion deem fit.
